- Speeding 25 miles per hour over posted limit \$6.50 per plus \$134.00 court costs
- Commercial Vehicle \$10.00 per mile over posted limit plus \$134.00 court costs
- Offenses in a Construction Zone where workers are present: double the regular fine plus \$134.00 court cost
