Events hours are 10 a.m. – 4 p.m. on December 4, 2021.

**Arts & Crafts** booths are approximately 10'x10'. Limited electricity is available on a first-come, first-served basis. This indoor/outdoor event will have limited indoor booths in the City Hall auditorium and the outdoor booths will be set up at the Heritage Square Park Pavilion.

**Food vendors** preparing food on-site will be outdoors in a 15' x 15' space, and must also comply with Williamson County Health Department regulations. It is your responsibility to contact their office for their permit. **NO cooking of food may take place indoors.**

Fees: Inside Booth - \$75 / Outside Booth \$50 / Electricity - \$10.

Credit card payments are accepted with an additional \$3.00 service fee.

General Rules: Booth set up begins at 7:00 a.m. and must be complete by 9:45 a.m. Take down may not begin until 4:00 p.m. If you are a vendor for a company that allows only one representative at an event, we will accept the first completed application submitted with payment. Confirmation information along with set-up information will be sent out the week of the event.
