



Pre-Development Meeting Request Form

The purpose of a Pre-Development Meeting (or Pre-App) is to provide property owners/developers with an opportunity to discuss their proposed development project with City staff in a single conversation at a preliminary stage. The meeting is for informational purposes only and does not constitute pre-approval of any development project. The City will provide written meeting notes following the meeting. A fee of \$500 is charged for a Pre-Development Meeting.

A COMPLETED PRE-DEVELOPMENT MEETING REQUEST MUST BE SUBMITTED BEFORE A MEETING CAN BE SCHEDULED.

Pre-Development Meetings:

- Requests must be received at least 7 days prior to the proposed meeting by 12 P.M. Staff will ensure application completeness and request payment.
- By appointment only, every Wednesday morning (9 AM – 12 PM), generally in 30-minute increments.
- Can be held in person at City Hall (400 Porter Street, Taylor, TX 76574) or as a virtual meeting or a combination of both.

Pre-Development Checklist:

Upload all required documents* to the Pre-Development Request generated through MyGovernmentOnline/MyPermitNow.

- ☐ *Submit a Completed Pre-Development Request Form.
- ☐ *Submit an Agent Authorization Form signed and notarized by all parties (as applicable).
- ☐ *A dimensioned Concept Plan showing the proposed layout of the site (building footprints, connections to utilities, impervious surfaces (parking lot – if applicable), general location of drainage/detention).
- ☐ *Provide a pre-determined list of questions for staff to guide the Pre-Development meeting.
- ☐ Acknowledgment that the applicant has viewed the City of Taylor Interactive GIS Map (showing the location of utility lines, zoning, and constraints)
- ☐ Acknowledgment that the applicant has reviewed the Envision Taylor Comprehensive Plan (showing growth sector, thoroughfare, and future land use designations, etc.)
- ☐ Acknowledgment that the applicant has reviewed the Land Development Code and the City of Taylor Engineering Manual
