This year will be an indoor/outdoor event with booths also being set up in the parking lot. Inside booths will also be on a first-come, first served basis.**

**Please remember that any food vendors must comply with Williamson County Health Department regulations. It is your responsibility to contact the Health Department. NO cooking of food may take place inside the venue. All vendors preparing food on-site will be located outside in the parking lot.**

General Rules: Booth set up by 9:45 a.m. with vehicles moved to designated parking areas. Take down may not begin until 4:00 p.m. Food items, such as homemade jams, jelly, specialty mixes, cakes, cookies, candies, etc. are welcome. If you are a vendor for a company that allows only one representative at an event, we will accept the first completed application submitted with payment. Confirmation information along with set-up information will be sent out prior to the event.

Organizers of this event may, at any time, arbitrarily, unilaterally and without advance notice, restrict the right to sell, display or distribute any material or merchandise that it determines, in its sole discretion, is in bad taste or that does not meet the image that Organizers desire to portray. No use, possession or sale of alcohol is permitted, nor are illegal drugs and/or firearms permitted anywhere on the grounds. No political or campaign material may be distributed or displayed. No printed materials may be distributed without prior approval of the Organizers, including sexually explicit materials, promoting the use of drugs or tobacco or any other topic deemed inappropriate by the Organizers. Due to space constraints, this Bazaar will strictly be limited to the sale of merchandise.
